PRODUCT INFORMATION

Intended Use	This kit is used for rapid qualitative analysis of erythromycin in milk (Raw milk, pasteurized milk, pure milk, milk powder).
Reagents And Materials Provided	 Test strips: 8 strips. Red dry powder microporous, 8 wells/bottle. Desiccant
Storage	2-8°C in cool dark place, do not freeze. The kit will be valid in 12 months. The lot number and expired date are printed on the package.
Specimen Collection And Preparation	Milk powder: Dilute the milk powder with the deionized water in the weight of 1:9 and test.
Assay Procedure	1. Read the instructions carefully before experiment. Bring the test kit and samples to room temperature. Milk samples should be fully liquid without any agglomeration and deposition. 2. Take bottles needed from the kit package, take out required wells and strips, and make proper marks. Please use these test strips within 1h. Seal the cap of the bottles. 3. Take 200µl of the test samples into the wells, then repeatedly absorb for 5 times, mix the sample with the reagent in the wells completely. Requirements: No solid matter observed with eyes (this step is very important). 4. Incubate for 5min at 40±2°C, insert the test strips into the wells with the "MAX" end fully dipped in to the mixture. (Printed with MAX line end facing down) 5. After 5 minutes, interpret the results according to the schematic diagram. Interpretation at other times is invalid.
Interpretation Of Results	T line > C line: Negative, Erythromycin in the sample < Detection limit T line=C line: Weak positive, Erythromycin in the sample = Detection limit T line < C line or T line no color: Positive, Erythromycin in the sample >


