### **Stability And Reactivity:**

**Thermal decomposition:** > 275°C (527 deg F).

**Conditions to avoid:** Humidity; Contact with water, acids, heavy metals (lead, copper), metal salt, bromine, methylene chloride, carbon disulfide, sulfuric acid, halogenated, hydrocarbons.

**Reaction Hazard:** May liberate toxic gas.

### **Potential Acute Health Effects**

**Inhalation:** Highly toxic if swallowed (R28): Causes irritation of mouth, pharynx, gullet and gastrointestinal tract.

## **SECTION 4: First Aid Measures**

**General advice:** Consult a doctor and show this safety data sheet.

**Eye contact:** Flush eyes with plenty of water for at least 10 minutes, occasionally lifting the upper and lower eyelids.
