### **Stability And Reactivity:**

**Thermal decomposition:** > 275°C (527 deg F).

**Conditions to avoid:** Humidity; Contact with water, acids, heavy metals (lead, copper), metal salt, bromine, methylene chloride, carbon disulfide, sulfuric acid, halogenated, hydrocarbons.

**Reaction Hazard:** May liberate toxic gas.

### **Potential Acute Health Effects**

## **SECTION 4: First Aid Measures**
